What is this product?

Type of product

Capital Four Funds ICAV (the "Fund") is an umbrella Irish collective asset-management vehicle with segregated liability between sub-funds formed in Ireland under the Irish Collective Asset-management Vehicles Act 2015 and authorised by the Central Bank of Ireland as a qualifying investor alternative investment fund.

Term

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

Please refer to the Prospectus of the Fund for further details on closure of sub-funds.

Objectives

The Sub-Fund invests in European credit related instruments, such as bonds and loans, or structured credit instruments. The investment objective of the Sub-Fund is to generate total returns and to achieve a return in excess of the benchmark. The benchmark consists of 50% Credit Suisse Institutional Western European Leveraged Loan Index, 100% hedged to EUR, and 50% ICE BofAML Euro High Yield Index, also 100% hedged to EUR. The Sub-Fund intends to achieve its investment objective by investing, either directly or indirectly, in a diversified portfolio of on average 80 – 100 bonds, loans and other types of debt and debt-related instruments across credit markets.

Intended retail investors

The Fund is intended for qualifying investors only who are able to make an informed investment decision based on this document and the Prospectus, and who have a risk appetite consistent with the risk indicator below.

What are the risks and what could I get in return?

Risk Indicator

Recommended Holding Period (RHP): 5 years
